Other Relevant Information

We note the following changes in the current POR, Mrs Presentacion S. Ramos' direct shares decreased from 125,000 to 100,000 shares as the 25,000 shares were categorized as indirect shares, since these are SRO shares (2009) held by Alakor Securities for the BO of Mrs. Ramos. Adrian Paulino S. Ramos, from 1,250,000 Direct shares, 250,000 shares were transferred to Indirect (SRO 2009). The increase in the direct shares of Maureen Alexandra Ramos-Padilla were acquired through inheritance, as previously disclosed on August 1, 2025 (23-B Report of Directors and Officers). Likewise, the additional indirect shares of Presentacion Ramos and Adrian Paulino S. Ramos, which were previously disclosed as direct shares, were subsequently lodged with PCD and became indirect shares.

Christopher M. Gotanco, from 4,860,025 Direct shares, 2,907,325 shares were transferred to Indirect shares (SRO 2009). National Book Store, Inc.'s 16,735,965,802 direct shares were reclassified as Indirect Shares (SRO 2009). Alakor Corporation's 16,735,965,801 Direct shares reclassified to Indirect (SRO 2009). Anglo Philippine Holdings, Inc.'s direct shares of 536,170,330, some 427,234,066 shares were reclassified as Indirect shares as these were acquired thru SRO 2009, under Alakor Securities account. While the Estate of Alfredo C. Ramos has remaining 5,000 direct shares, under a lost stock certificate that was not included in the EJS, but is still subject of the amended EJS. From 690,088,350 direct shares, 690,083,350 shares were transferred to the heirs (PSR, AR MARP, ASR).
