Description of the Disclosure

The attached Annex A, as revised, indicates the beginning balance of 32,274,744,754 OV shares (as of August 31, 2025), plus the total lodgment of 575,069,458 in September, which includes the 345,041,675 shares of Presentacion S. Ramos, the 115,013,891 shares of Adrian Paulino S. Ramos, and 115,013,892 shares of Gerard Anton S. Ramos, all acquired thru inheritance, as previously disclosed on August 1, 2025 (23-B Report of Directors and Officers). Note that these shares were previously direct shares then subsequently lodged thru PCD and became indirect shares.

With the disposition of shares beneficially owned by Gerard Anton S. Ramos from September 23 to 26, 2025 totaling 90,013,892, the ending balance of OV shares held by Alakor Securities Corporation as of September 30, 2025 is at 32,759,800,320.




